6. Open Tender enquiry:

- The vendor shall provide a detailed support escalation matrix with contact information for Level 1 (L1) and Level 2 (L2) support personnel, including phone numbers and email addresses
- The vendor shall replace defective parts with new and genuine spare parts of the same make and model. If an item is obsolete, the vendor shall replace it with an equivalent or superior model, subject to written approval from the security officer
- The vendor shall perform preventive and corrective maintenance of the entire CCTV system every quarter. This includes cleaning camera lenses, checking cables and connections, inspecting junction boxes, ensuring proper network and power functionality, and addressing potential issues (e.g., rodent entry into junction boxes). The vendor will also perform system diagnostics and software updates as required
- The vendor shall ensure the smooth operation of the CCTV surveillance system, including tasks such as removing and re-fixing cameras, configuring CCTV servers, storage, and clients, resolving software issues, and addressing connectivity or switch configuration issues
- The vendor shall maintain sufficient spare parts along with components and tools necessary for system maintenance
- The vendor shall change the passwords for the entire CCTV system, including cameras, switches, servers, and display systems, once every six months, in coordination with and upon approval from the security officer

- The entire UTP cabling between the switch and CCTV is covered under AMC; any faults shall be restored by the vendor

- Upon completion of each service call, the vendor shall generate a comprehensive service report detailing the nature of the fault, the work performed, and any parts replaced, which must be approved by the security officer
